



Release Agreement

In consideration of me being permitted to participate in the Vet + Pet West Wag pet expo and learning event (collectively the "Event") owned and produced by UBM Animal Care ("UBM"), from December 15 - 16, 2018, at the San Diego Convention Center (the "Venue"), I agree to the following terms and conditions of this Release Agreement:

I agree to the terms of this Release Agreement.

I acknowledge and agree that by signing this Release Agreement, I am releasing UBM and any other sponsoring or organizing parties, including, but not limited to the Venue the State of California, property owners, law enforcement agencies, or public entities associated with the Event, their respective affiliates and companies, and their respective shareholders, directors, officers, employees, agents, contractors, successors and assigns ("Released Parties"), from any and all liability for any acts, omissions or occurrences which may result, directly or indirectly, in injury to myself, my pet, or my personal property, as a result of my participation in or association with the Event, including travel to and from Event, and I hereby agree to waive, release and forever discharge, on behalf of myself and my heirs, executors, administrators, legal representatives, assignees, and successors in interest, any and all claims for damages, rights or causes of actions which I may have, or which may hereafter accrue, against the Released Parties, including any claims arising from the Released Parties' own negligence.

I hereby agree to indemnify and hold harmless the Released Parties from any claims, rights or causes or actions which may accrue to any individual or entity participating in, involved with or present at Event as a result, directly or indirectly, of my own acts or omissions, or the acts or omissions of my pet, during my participation in or association with Event, including travel to and from Event, and that I shall indemnify the Released Parties for any damages awarded or expenses incurred as a result of any such claims, rights or causes of action, including, but not limited to, attorney fees and court costs.

I affirm that my pet dog(s), cat(s), or ferret(s) attending Event is/are currently vaccinated against rabies. I affirm that my pet is not known to be vicious, and that it is free of any disease or condition which would make it a danger to any participant, spectator, or other individual or animal. I accept all liability for damage to property, persons, or animals caused by myself or my pet.

I hereby understand and agree that this Release Agreement is a contract which has legal consequences and agree that I have read all its terms, fully understand them, and am legally competent to execute this Release Agreement. This Release Agreement can only be modified by separate written instrument signed by the parties hereto. I hereby agree that this Release Agreement is intended to be as broad and inclusive as is permitted by the laws of the State of New York and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
